Opening and welcome



Richard Howitt, First elected in 1994 he has served as Rapporteur on CSR over three successive European Parliaments and represents European interests across international CSR initiatives, as a Friend of the OECD Guidelines on Multinational Enterprises, a Member of the Governmental Advisory Group of the Global Reporting Initiative (GRI) and a member of the Public Policy Advisory Group of the United Nations Principles for Responsible Investment (UNPRI).Currently working towards greater non-financial reporting for 50,000 large EU companies, Richard Howitt has also been involved throughout the genesis of the International Integrated Reporting Council (IIRC) for which he is proud to be an Ambassador.



Erik Nooteboom is Head of the Unit "Accounting and Financial reporting" in the DG for Financial Stability, Financial Services and Capital Market Union within the European Commission. Previously he headed the "Industrial Property", the "Public Procurement" and the "Retail Finance and Payment" policy units, and he was acting director for "EU and international Public procurement policy"; all in the same DG. He studied law in Amsterdam and joined the European Commission in 1987 after 5 years in the Dutch Civil Service "Ministry of Economic Affairs).



Paul Druckman is Chief Executive Officer of the IIRC. Paul is well known and respected in business and in the accounting profession worldwide. Following an entrepreneurial career in the software industry, Paul operated as a non-executive chairman and director for companies in a variety of sectors until taking over this post. Formerly a Director of the UK Financial Reporting Council; member of the City Takeover Panel; and President of the Institute of Chartered Accountants in England and Wales (ICAEW). Other interests have included chairing The Prince's Accounting for Sustainability Project (A4S) Executive Board.
