SPEAKERS

JYOTI BANERJEE



Jyoti Banerjee has advised the International Integrated Reporting Council since its inception, focusing on strategy, innovation and new projects. Prof. Dr. W. Schneider became President of Accountancy Europe in December 2016, after he had joined its board in 2013. WHAT FUTURE FOR THE PROFESSIONS?

RICHARD SUSSKIND



Professor Richard Susskind OBE is an independent author, speaker, and adviser to international professional firms and national governments. He is IT Adviser to the Lord Chief Justice of England and Wales, Chair of the Advisory Board of the Oxford Internet Institute, and President of the Society for Computers and Law. He lectures internationally and has been invited to speak in over 40 countries. He has written numerous books, including the bestsellers, *The End of Lawyers?* (2008) and (with his son, Daniel Susskind) *The Future of the Professions* (2015). His work has been translated into 12 languages. In 1986, he obtained a doctorate in law and artificial intelligence from Balliol College, Oxford.

DANIEL SUSSKIND



Daniel Susskind is a Fellow in Economics at Balliol College, Oxford, where he teaches and researches. He is an independent adviser to professional firms and national governments. Previously he worked in the British Government – as a policy adviser in the Prime Minister's Strategy Unit, as a policy analyst in the Policy Unit in 10 Downing Street, and a senior policy adviser in the Cabinet Office. His book, The Future of the Professions (2015, paperback, 2017), coauthored with Richard Susskind, was widely acclaimed. It was a Financial Times 'Book of the Year', a Times Literary Supplement 'Book of 2016', and a New Scientist 'Best Read of 2015'.

MONA DE BOER



Mona de Boer is a Director in the assurance practice of PwC, where she leads a programme aimed at the innovation and transformation of the audit through data analytics. Mona has a specific interest in exploring how technological developments like robotics, the internet of things, digitalization, data standardization and increased network and system-connectivity lead to the advent of 'robot assurance'.
