#### **WIM BARTELS**

#### **MARK VAESSEN**

#### **HANS HOOGERVORST**



Hans Hoogervorst is a former chairman of the executive board, the Netherlands Authority for the Financial Markets (AFM), and a former chairman of the IOSCO technical committee. He was appointed as cochair of the Financial Crisis Advisory Group to advise the IASB and the FASB on their joint response to the financial crisis. Between 1998 and 2007 Mr Hoogervorst held a number of positions in the Dutch Government. Prior to this he served both as a member and senior policy advisor to the Dutch Parliament and the Ministry of Finance. He also spent three years as a banking officer for the National Bank of Washington in Washington, DC. Mr Hoogervorst holds a Masters degree in modern history (University of Amsterdam, 1981) and a Master of Arts degree in international relations (Johns Hopkins University school of advanced international relations, majoring in international economics and Latin American studies).

# Q&A: REACTION ON THE KEYNOTE SPEECH, THE COGITO PAPER, AND THE CALL FOR ACTION

#### RICHARD HOWITT



Richard Howitt is Chief Executive Officer of the International Integrated Reporting Council. As such he is spearheading the adoption of Integrated Reporting globally and is a major thought-leader in international debates on good corporate governance, shifting investment to the long-term and inclusive capitalism. Prior to being appointed to the IIRC, Richard travels extensively internationally to meet with the over 1,500 global businesses who are adopting Integrated Reporting as well as with advocates of Integrated Reporting in policy and investor communities. He is a member of the B20 group of international business leaders who dialogue with G20 governments. Richard served as an elected Member of the European Parliament for over twenty years and was rapporteur on corporate responsibility. In this capacity, he was key architect of the EU's non-financial information directive, one of the biggest transformations in corporate disclosure anywhere in the world.

#### ADRIE HEINSBROEK



Adrie Heinsbroek has a degree in social anthropology, has been working in the field of corporate responsibility and responsible investing since 1996. Always interested in the sustainability approach and link with the business strategy of companies and organizations and their disclosure on these topics. Currently his responsibilities combine the integration of sustainable factors into the investment process and provide direction to the active ownership responsibilities.

#### **ELS DE GROOT**



Els de Groot worked from 1987 till 2010 in the financial sector, as Executive Vice President Global Risk Management of ABN AMRO Bank and CFO/CRO of Van Lanschot Bankiers. Subsequently, she was CFO of Royal Schiphol Group and as such member of the Managing Board, till early 2017. Royal Schiphol Group participated in the Integrated Reporting Pilot Programme 2011 and received a number of nominations and awards for its annual report. She currently holds various non executive board positions.

#### **MASSIMO ROMANO**



Massimo is an "evangelist" of Integrated thinking and reporting. In the last 12 years Massimo has evolved his role in the financial reporting area starting as project manager of the IFRS implementation in Generali Group. Currently he is program leader of "Galileo", a global multi years transformation program of the CFO finance platform, focused on streamlining the reporting process, improving the global disclosure of the Group and leveraging the best IT solutions. Massimo is also active in some international working groups on corporate reporting issues: he is the chair of the Steering Committee of the CFO Forum, a high-level discussion group formed by the major European listed insurance companies. In 2014 he set up and co-chaired with Aegon the Insurance Business Network under the IIRC to spread the "gospel" of Integrated reporting and thinking among the Insurance Sector. In 1994 Massimo graduated (Summa Cum laude) in Economics and qualified as a Chartered Accountant in Italy in 1996. Born in 1971, Massimo lives in Italy with his wife & three kids.

#### IAN MACKINTOSH



Ian Mackintosh was a partner of Coopers and Lybrand for 20 years in Australia and the Pacific. Subsequently he was Chief Accountant at the Australian Securities and Investment Commission and also worked at the World Bank in Washington. In 2004 he was appointed as Chairman of the UK Accounting Standards Board, a position he held until he was appointed Vice Chairman of the IASB in 2011. His term in that role finished in 2016. He now has several roles including Chair of the Corporate Reporting Dialogue and Chair of the Financial Reporting Advisory Board at the UK Treasury.

#### **ROBYN LEESON**



Robyn Leeson has a long association with the Global Reporting Initiative, having previously served on GRI's Stakeholder Council, Technical Advisory Committee and Public Sector Working Group. She has held numerous positions in the public sector in Australia, including roles with regulators such as the Environment Protection Authority. She has also worked as a consultant, advising a variety of Australia's listed companies on the development of their sustainability strategies, programs and disclosures. Robyn holds a PhD in environmental impact assessment and a Masters degree in environmental sciences.

#### **ANDREAS BARCKOW**



Andreas Barckow was appointed full-time President of the ASCG as of 1 March 2015 and represents Germany on the IASB's Accounting Standards Advisory Forum (ASAF) and the EFRAG Board, where he also serves as its Vice President. Before joining the ASCG, he was the lead technical partner for accounting matters in the German member firm of Deloitte in Frankfurt and a member of their Global IFRS Leadership Team. During that time, Andreas had also been a member of different standard-setting bodies of the ASCG for more than ten years. He graduated with a Diploma and a Doctorate in Business Administration from the University of Paderborn. He currently serves as an Honorary Professor at the WHU - Otto Beisheim School of Management in Vallendar.

#### **PATRICK DE CAMBOURG**



Patrick Cambourg, a graduate from Sciences Po Paris, holds also degrees in public law and in business law and is also bachelor in Arts. As chartered accountant and auditor, he has spent his entire career until 2014 within the Mazars Group, successively as junior, manager, and partner. He became President of Mazars in 1983. In 1995, he was appointed as Chairman of the Management Board of the then newly created international partnership, and he became in 2012 Chairman of the Supervisory Board. Since late 2014, he is Honorary President of the Mazars Group. Since March 2015, Patrick de Cambourg is President of the Autorité des Normes Comptables (ANC), the French accounting standards setter. As such, he is also a member of the Board of the French Financial Markets Authority (AMF), of the French Banking and Insurance Supervisory Authority (ACPR) and of the French Consultative Body for public accounting standards (CNoCP). He is also a member of the French Financial Stability Council (HCSF), of the Board of EFRAG (European Financial Reporting Advisory Group) and of ASAF (Accounting Standards Advisory Forum). Patrick de Cambourg is Knight of the "Légion d'Honneur" and Officer of the "Ordre National du Mérite".

#### **ROXANA DAMIANOV**



Roxana Damianov is a Team Leader within the Investors and Issuers Department. ESMA is an independent EU authority that ensures the integrity, transparency, efficiency and orderly functioning of securities markets, as well as enhancing investor protection. Her role covers coordination of ESMA activities in relation to corporate reporting, auditing, prospectuses, securitisation and credit rating agencies policy. Her previous roles include working at PricewaterhouseCoopers in which she had technical managerial positions in activities related to the audit, technical review of IFRS financial statements and transactions on capital markets. Roxana is ESMA representative in the EFRAG Board, the CEAOB (Committee of European Audit Oversight Bodies) and IFRS Advisory Council.
