# The Federation of European Accountants (FEE) calls for unified global standards to mitigate climate change

The importance of the forthcoming climate conference in Copenhagen cannot be overstated. We must all hope that those representing the nations of the world can achieve an outcome that can lead to greenhouse gas emissions being kept below the critically dangerous thresholds that are otherwise imminent. A successful outcome in Copenhagen will still leave much important work to be done in achieving the necessary progress.

Instrumental in this process of controlling greenhouse gas emissions will be the measurement, control, reporting and verification of greenhouse gas emissions. These are the traditional areas of expertise of the accountancy profession. Reliable greenhouse gas information is crucial as a basis for the decisions to be taken by management, investors, stakeholders, policymakers and regulators.

Accountants have contributed to existing frameworks for the implementation of, and for assured reporting on, a range of sustainability measures, including the control of greenhouse gas emissions. While much has been learned during the course of this progress, there remains a need for the development of a clear, consistent and authoritative reporting framework.

FEE urges policymakers to work with professional accountants and others to achieve a rigorous and trusted unified global reporting regime that can help to achieve a reduction in emissions and commends IAASB¹ for having published the Consultation Paper on Assurance on a Greenhouse Gas Statement. FEE believes that it is in the best interests of all parties to see carbon measurement, disclosure and assurance approaches standardised.
