## European Accountants call for a specific international standard on sustainability assurance

Corporate Social Responsibility reporting now ready for a specific standard, says FEE

Tuesday 13 June 2006 – BRUSSELS – The European Federation of Accountants (FEE) today published its most recent paper in the Sustainability Assurance series. In publishing this work, FEE has concluded that there is a need for a more specific international standard for assurance on corporate social responsibility reports. FEE has called on the International Federation of Accountants (IFAC) to build on the current national standards in this area and to develop an international standard for sustainability assurance. FEE recognises the overall importance of, and strongly supports, the current major project to clarify the International Auditing and Assurance Standards Board (IAASB) Engagement Standards, which requires considerable resources and priority.

In researching this paper, FEE reviewed the existing European standards for sustainability assurance used in Sweden, France, the Netherlands and Germany. Through a comparative examination of current standards, FEE has analysed the differing practices in this area and indicate where further international guidance would be desirable. The paper concluded that the ISAE 3000, IAASB's current standard for assurance of non-financial information, is too general in nature due to the complexity and specificity of the subject of sustainability.

"Increasing demands by investors and other stakeholders for high-quality, reliable information makes the business case for assurance provision", noted Chairman of the Sustainability Assurance Subgroup, Lars-Olle Larsson. "An international standard in this area will therefore lead to greater transparency in an increasingly complex global marketplace, benefiting both companies and consumers."
